Chuvangin anmahni kha khualzin an ni ngei a, an chet velna chu inthlanpui nen a inkaihhnawih lo a ni tih finfiah felfai mai kha a tawk a, tul lovah an tan harsatna dang thlen loh tur a ni.

May ni 29, 2015- a ECI in SOP a tihchhuah [Annexure G7 of Compendium of Instructions on Election Expenditure Monitoring (January, 2024)] ah chuan Candidate, Agent, Party Worker ten tum khatah tangkafai Rs 50,000/- aia tam an pai thiing lova, party bungrua pawh tum khatah Rs 50,000/- aia tam phurh phal a ni lo. Hei hi phal chin bak aia tam sum dik lo taka hman ven a nih theih nan a ruahman a ni.

FS/STT zawng zawng hi District-a senior officer, a bika ruat ten an ho thin a, videographer leh police ralthuam keng ten an puibawm thin a ni. Chuvangin endik hna pawh taima tak leh hawihawm takin, midangte zah thiamna nen an kalpui thin tur a ni. An lakah mipuite lungawilohna a thlen loh nan District Election Officer leh Superintendent of Police ten uluk takin FSs (Flying Squads) / SSTs (Static Surveillance Teams) te hnathawh dan an vil thin tur a ni a, SOP zawm lo FSs/STTs officialte chungah dan angin hremna lek a ni ang.

Chief Electoral Officer-in District Grievance Committee-te chu tha takin hna an thawk em tih a vil tur a ni a, thutlukna siam ngai pawh tikhawtlai lovin rang takin an chingfel zung zung tur a ni.
