

The Election Department placed before the DPC to consider filling up of 1 (one) post each of LDC on regular basis under Election Branch of Mamit, Champhai, Kolasib, Serchhip and Lawngtlai District which was created vide Order No.A.11013/1/2017-CEO dated 10.10.2017 for which permission for filling up of the said posts by direct recruitment was concurred by DP&AR (ARW) and Finance Department vide their I.D.No.ARW/CEO/2017-2018/C-420 dated 14.03.2018 and I.D.No.FIN(E)30/2018 dated 10.05.2018 respectively.

Advertisement for the said posts was published in two local newspapers through I& PR. 842 applications were received and written examination was conducted on 4.08.2018 at MPSC Examination Hall. Typing test/ Practical Exam was also conducted at I& CT Department. Hall, Khatla on 20th & 21st August, 2018.


As per norms prescribed by the Mizoram Direct Recruitment (Conduct of Examination) Guidelines, 2018, 13 candidates who secured highest marks (Theory + Practical) are selected to have been qualified for Personal Interview.


12 (twelve) candidates appeared before the DPC for Personal Interview. The DPC, based on the cumulative marks obtained by each candidate in the written plus Practical examination and the performance of each candidate in the personal interview, recommends the following persons (in order of merit) for appointment to the post of LDC.
