Subject: Schedule for General Election to 17th House of the People (Lok Sabha).

Election Commission of India (ECI) chuan Press Note vide ECI/PN66/2018 dt. 10th March, 2019 chu tichhuakin **General Election to the House of the People (Lok Sabha), 2019** siamna atan Inthlanpui chu chhawng 7-a neih a nih tur thu a puang a. 1-Mizoram (ST) Parliamentary Constituency bika inthlanpui chu ni 11.04.2019 ah neih a ni ang. He inthlanpui rual hian 15 – Aizawl West (ST) AC ah bye election neih a ni dawn bawk a ni. ruahmanna leh inpuahchahna kalpui mek leh kalpui dan tur chu hetiang hi a ni:-

1. **Electoral Data:-** ECI in Mizoram-a District 8-a ni 1.1.2019 qualifying date-a hmanga Special Summary Revision of Electoral Rolls a kalpui a, Final Electoral Rolls chu ni 22.3.2019 khan tihchhuah a ni a, tun dinhmunah (10.03.2019) vote nei thei chu mi 784405 an awm a, heng zinga mi 381991 hi mipa an ni a, 402408 hi hmeichhia an ni. District 8-a inthlan neihna tur hmun 'Polling Station' awm zat leh District-wise voter awmzat chu hetiang hi a ni:-

2. **Identification of Electors:-** Vote thlak turte reng rengin, Polling Booth-a an nihna tihchianna'n Elector's Photo Identity Card (EPIC) an hmang tur a ni a, Voter Slip ringawt hmang chuan nihna tihchian phal a ni tawh dawn lova, EPIC bakah Aadhaar Card leh addl. document 10 te chu hman a ngai ang.

3. **Law & Order and Deployment of Forces**:- Inthlanna muanawm leh felfai neih a nih theihna atan, dan leh thupek kenkawh kawnga mawhphurtute chu a tul anga hma la tura tih an ni a, a bik takin District Magistrate leh Superintendent of Police -te chu ruahhmanna tul ang zawng zawng siam tura tih an ni. State Police bakah Central Armed Police Force(CAPF) ten venhimna hna an thawk dawn a ni. Polling Station thlan bik 100-ah web-casting tih a ni dawn a ni.
4. **Election Officials**:- Deputy Commissioner-te chu District Election Officer (DEO) atana ruat an ni a, Inthlanna buaipitu Aizawl DC chu Returning Officer a ni anga , amah bakah hian Asst. Returning Officer tur mi 9 ruat an ni bawk.
5. **Election Observers & Sector Officers**:- General Observer, Expenditure Observer, Police Observer leh Micro Observers an awm ang a, anni hian inthlan chungchanga hma lak dan ngun takin an vil dawn a ni. Inthlan kalpui dana lungawilohna emaw sawisel duh neite chuan an biala Observer-te an hriattir thei ang. Observer bakah hian Sector hrang hrang vil turin Sector Officer ruat an ni bawk.
6. **Conduct of Officials**:- Election Commission of India(ECI) chuan inthlanna buatsaihna kawnga mawhphurtu, Police-te tiamin, Sawrkar hnathawk zawng zawngte chu duhsak bik emaw hlauhna nei hauh lova a lai thei ang bera hna thawk turin a beisei a. An zavai hian ECI hnuai deputation-a kal anga ngaih an ni a, election process a zawh hma chuan Commission thuneihna hnuai an awm dawn a ni.
7. **Innovative Measures /New Initiatives**:- Tun tum inthlanpui-a thil thar leh danglam ruahman thenkhatte:
 - 1) **VVPAT**: Tun kum inthlanah hian EVM bakah VVPAT Polling Station zawng zawngah hman a ni dawn a ni.
 - 2) **All Women Managed Polling Stations**: Assembly Constituencies tinah polling station 10% zel chu hmeichhia chauhin an enkawl dawn a. Heng Polling Station te hi Mizoram ah chuan Dingdi Polling Station tih an ni a, heng Polling Station ah te hian polling staff bakah police leh security zawng zawng hmeichhia an ni vek ang.
 - 3) **Booth Level Planing**: Booth Level Planning for Polling Stations mumal tak siam tur a ni a, he plan hian standard operating procedure a keng tel ang.
 - 4) **E-Payment Gateway for Goods and Services**: Payment zawng zawng hi E-payment Gateway kal tlingin pek chhuah tur a ni viz - (i) Timely Payment for all the Civilian Officials/Police Officials deployed for "Election Duties" (ii) Timely Payment to all the Owners of the Vehicles which are Requisitioned for Election Purpose.
 - 5) **Registration of Service Voters and ETPBS**: MP inthlanpui-a a vawikhatna atan Mizoramah tun tum Inthlanpui ah hian ETPBS (Electronically Transmitted Postal Ballot System) hi service voters ten state pawn atanga vote rang zawk a an thlak ve theihna atan ECI chuan a ruahman a ni. Polling personnel tan erawh chuan Postal Ballot niloin Election Duty Certificate (EDC) issue a ni ang.

- 6) **Friendly polling stations for PwDs:** Rualbanlo/vohbik elector-te tan polling station tinah an vote thlak awlsamna tur special facilitation voting ruahman sak leh an ni ang.
- 7) **C-VIGIL App:** Model Code of Conduct bawhchhiatna thleng thinte hi mipui mimirin complaint an siam zung zung theih nan ECI chuan c.VIGIL App a duang chhuak a. Complaint registered anih hunah unique ID no. pek chhuah hmangin an complaint dinhmun chu a chhui zui thei dawn a ni. c- VIGIL App system-ah complaint a lo luh veleh chu complaint chu District Control roomah thawn a ni anga, chu chu Flying Squad ten dawng chhawngin hma an lo dawn a ni. An report chu Returning Officer/Asst.Returning Officer ten a lo hmuh hunah , a tul angin hma a la ang.
- 8) **Photo Voters Slips (PVS) :** Voter-ten an vote thlakna tur polling station leh Electoral Roll-a an serial no. theuh an hriat lawk theih nan official voter slip an thlalak chuang chu inthlanni hma ni 5 chhungin District Election Officer ten Booth Level Officer kal tlangin an sem dawn a ni.
- 9) **Assured Minimum Facilities (AMF):** Election Commission of India chuan Polling Station upgrade-in heng- thui in tur, toilet, ramp, standard voting compartment etc voter-te tana awlsam taka vote thlak theihna tura awm vek turin ruahmana a siam bawk a ni.
- 10) **MCMC:** State leh District level-ah Media Certification and Monitoring Committee(MCMC) chu din vek a ni ang a, Political advertisement reng reng reng chu an endik hmasa thin dawn a ni.
- 11) **New Suvidha App:** ECI in a siam Single window Permission System chu phalna hrang hrang hrang bakah Vote counting leh Nomination tihna tur a ni dawn a ni.
- 12) **Other Mobile Apps:** Voter Helpline app, PwD Helpline app, etc. te hi tun election a hian hman tur a ni a, heng mobile app te hi google Play Store ah download theihin a awm a ni.
- 13) **1950:** Toll free number, 1950 hi election chungchang engpawh zawh fiah theihna tur a ni a, complaint pawh hi number ah hian call in a theihluh theih a ni. Nitin 9am atanga 9 pm chhung heta toll free number a call te dawng turin District Contact Centre te an in hawng dawn a ni.

3. **Model Code of Conduct:-** 'Model Code of Conduct for General Election to Mizoram Legislative Assembly' chu ni 10th March, 2019 atang hian hman tan nghal a ni a. He Model Code hian Political Parties, Contesting Candidates, Ministers, Members of Parliament, Members of Legislative Assembly, Chief Executive Member, Executive Members, Members of District Council leh Public Servant-te a huam ang.
