Assembly Constituency /Segment tinah hmeichhe hlangin an vil leh Persons with Disabilities-ten an vil polling station pakhat tal awm tura hma lak a ni a. Hei bakah hian tualchhuak hmanraw hmanga siam leh hnam zia tilang thei tura chei Model Polling Station pakhat tal a awm bawkw dawn a ni. Tin, thalai ten inthlan an ngaih pawimawh deuh deuh a, nasa zawka an inhnawhawh ve theih nan District tina Polling Station pakhat tal chu inthlan buaipuitu (polling official) zinga naupang zual hlangin an vil bawkw ang. Commission thupek angin Critical Polling Station zawng zawngah leh Polling Station awm zawng zawng zatve aia tlem lovah vote thlak lai lo vilna turin *webcasting* tih tum a ni.
3. **Postal ballot/Home voting facility:** Hei chanvo hi PwD leh Senior Citizens (kum 85 leh a chunglam) ten an duha an hman theih turin ruahman a ni ang.
4. **Eco-friendly elections:** Election Commission of India chuan political party-te leh candidate-te chu single-use plastic leh tawih theih lo hmanrua hmanga campaign kalpui lo tur leh environment tana him hmanrua chauh hmang turin a ngenin a beisei a. Hriselna leh environment venhim a nih theih nan political party zawng zawng ten single-use plastic hmanga poster, banner, adt. hmang lo tur zawngin hma an la ngei tur a ni.
5. **Law and Order, Security Arrangements and Deployment of Forces:** Venhimna mamawh dan tur ngun taka chhut niin State Police mi 3000 chuang bakah Central Armed Police Forces (CAPF) Company 15 vel chu Inthlanpui neih turah hian duty-tir an ni ang.
6. **Election Expenditure Monitoring:** Election-a candidate-te sum hman dan ngun taka vil turin Assistant Expenditure Observers, Flying

Squads (FS), Static Surveillance Teams(SST), Video Surveillance Teams(VST), Video Viewing Teams(VVT), Accounting Teams(AT), Media Certification & Monitoring Committee (MCMC), District Expenditure Monitoring Committee (DEMC) te dah an ni a. Heng bakah hian Enforcement Agencies hrang - State Police, State Excise, State Tax, State Forest, Investigation Directorate of Income Tax Dept., CBIC, Enforcement Directorate, Financial Intelligence Unit (FIU-IND), DRI, RPF, BCAS, CISF, BSF, Assam Rifles, ITBP, ICG, Commercial Tax Department, Narcotics Control Bureau and Department of Post te chuan inthlan puan a nih atangin hna an thawk tan dawn a. State Excise Department chuan Mizoram Liquor (Prohibition) Act, 2019 chu khauh takin a kengkawh dawn a ni. Enforcement Agency hrang hrangte chu Election Seizure Management System (ESMS)-ah khung luh (onboard) mek an ni a; FS's/SST's tih loh, enforcement agencies dangte chuan March ni 1, 2024 atang khan an thil man an report zat zat tawh a ni.

7. **Use of Media:** Addl. Chief Electoral Officer, Mizoram kaihhruaina hnuaiiah State Level Media Cell din a ni a. Election laia Media hrang hrang tangkai taka hman a nih theih nan leh Media mite nena inpawhtlang tak leh anni nena thawh hona tha neih a nih theih nan Media Centre changtlung tak CEO Office-ah din a ni. Vote thlak ni leh vote chhian nia hman turin Accredited media-person te hnenah Authority Letter pek chhuah a ni ang. State leh District level-ah Media Certification and Monitoring Committees (MCMC) din a ni bawk a, electronic media-a chhuah tur political advertisement reng reng chu he Committee remtihna (pre-certification) nei a ni ngei tur a ni. Social media hman sualna leh paid news vil turin Addl. Chief Electoral Officer kaihhruai Social Media Cell pawh din a ni a, he Cell hian inthlan puan a nih atangin electronic, print leh social media-a thuchhuahte ngun takin a thlithlai dawn a ni.
8. **Training:** India International Institute of Democracy and Election Management (IIIDEM)-in training neih dan tur a duan ang takin District Level Master Trainers, Online Training on ESMS, EVM Management System 2.0, Certification program for AROs, I.T application, SVP leh ETPBMS training neih zawh fel a ni a. Election-a thawktute leh chanvo nei zawng zawngte'n tha taka an mawhphurhna an hlen vek theih nan District tinah vote thlak ni thlengin training hi neih chhoh zel tur a ni.
9. **Systematic Voters' Education and Electoral Participation (SVEEP):** General Election to the Lok Sabha, 2019 a vote tla zat, i.e. **63.13%** khum a nih ngei theihna turin vote tlak tlem thinna hmunah te, a mi cheng vil zual ngaihna hmun (vulnerable community)-ah te SVEEP hmangin hma lak zel a ni a. Heng hmunah hian vote thlak an punna turin District Election Officer/Assistant Returning Officer-te'n

ruahmanna (Turnout Implementation Plan) siamin hma an la chho mek a ni.

- 10. EVMs leh VVPATs :** Tun Inthlanpui-ah hian ECIL siam model thar ber M3 – EVMs/VVPATs hman a ni dawn a. Election Commission of India chuan inthlanna- a hman atana daih zan tur Voter Verifiable Paper Audit Trial (VVPAT) leh Electronic Voting Machine (EVM) a rawn dah tawh a. Khawl endik hna thawh khatna (First Level Checking of EVM/VVPAT) hi zawh fel tawh niin, tunah hian Inthlanpuia hman tur Ballot Unit **2158**, Control Unit **2195** leh VVPAT **2288** te chu District tina Strong Room-ah uluk taka venhimna hnuaiyah dah that thlap tawh a ni.
- 11. Air Ambulance :** Commission thuchhuak angin Inthlan hma ni leh Inthlan ni-ahte election-a thawktu official leh security mi damlohna avanga hmanhmawh taka damdawi in panpui ngai an awm palha phurh nan Air Ambulance ruahman a ni ang.
- 12. Model Code of Conduct (MCC):** Inthlan puan (announce) a nih chiah atangin Model Code of Conduct hi hman nghal a ni. MCC hi Mizoram pumah hman niin, candidate-te, political party-te leh Sawrkar hnuaiyah awm zawng zawngin an zawm tur a ni a, MCC bawhchhiatna reng reng chu umzui zat zat a ni ang. MCC-in a huam tel chin chuan MCC chungchanga thuchhuahte an chhiarin an hre bel hle tur a nih bakah an zawm ngei tur a ni.
- 13.
